PARTICIPANT LIABILITY WAIVER AND HOLD HARMLESS AGREEMENT

Please read this form carefully and be aware that by registering for and participating in this program, you will be waiving your rights to all claims for injuries or losses you might sustain arising out of this program and you will be required to indemnify, hold harmless and defend the *Village of Carpentersville* for any claims arising out of participation in the Carpentersville Improvement Committee activities (“Program”).

Carpentersville Improvement Committee activities are as scheduled by the Committee. During the activities scheduled the participants may mow lawns, clear brush, pick up trash, cut down tree branches and limbs, fix fascia and soffits, remove graffiti and may perform other small home improvement tasks as determined by the Committee.

I recognize and acknowledge that to participate in this program I must be at least 18 years old. I affirmatively state that I am 18 years old or older.

I affirmatively state that I do not suffer from any type of ailment, illness or disorder that affects or may affect the my ability to participate in the program and I assume any and all risk of injury (including death) with relation to any type of ailment, illness, disorder or abnormality, whether known or unknown.

The Committee reserves the right to deny participation to any person for any reason whatsoever.

Risk of Injury and Waiver of Claims: I acknowledge and agree that I am participating in this program voluntarily and at my own risk. As a participant in the program I recognize and acknowledge that there are certain risks of physical injury which may result from the activities of the program, which may include but are not limited to: mowing, lifting, carrying, climbing ladders and using power or other tools. I agree to assume the full risk of and to waive and relinquish any and all liabilities, claims, injuries (including death) damages or loss of whatever nature which I may sustain, directly or indirectly, as a result of participating in any and all activities associated with this program.

Release from Liability: I do hereby fully release and discharge the Village of Carpentersville and its officers, agents and employees from any and all liabilities, claims, injuries (including death) damages or losses of whatever nature, which I may have or which may occur, directly or indirectly, on account of participation in the program.

Indemnity and Defense: "I further agree to indemnify, hold harmless and defend the Village of Carpentersville and its officers, agents, and employees from any and all liabilities, claims, injuries (including death), damages or losses of whatever nature, arising from, as a result of, connected with, or in any way associated, directly or indirectly, with any of the activities of the program."

In the event of any emergency, I authorize the public entity to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed reasonable and necessary for my immediate care and agree that I will be responsible for payment of any and all medical services rendered.
